

July 23, 2019

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, July 23rd, 2019 with Chairman Tom Broeker, Vice-Chair Bob Beck and Member Jim Cary present.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: County Auditor Terri Johnson reported on attending the ISACA Conference last week. They discussed the county seal issue and proposed legislative language to correct. Along with the seal change, additional changes include new candidate filing deadlines for the 2020 primary and general elections. The change will eliminate the ability of a candidate losing a primary race from being able to file as an independent candidate for the general election. This will be further discussed at the ISAC Conference in August. Maintenance Supervisor Rodney Bliesener stated the finishing touches on the Jail Control Board room are complete. County Treasurer Janelle Nalley-Londquist reported her office is busy. They are finishing year end and working on mobile home tax statements. Public Health Administrator Christa Poggemiller reported they will have a First Aid booth at the county fair this week. This is their third year for providing this service. No clinics will be held at the health department due to the fair. Safety Director Angie Vaughan reported West Burlington asked for a quote to join the joint safety committee. Their current safety provider is raising rates and only provides online training. West Burlington will review the quote at a city council meeting. CDS Director Ken Hyndman attended a children's meeting with Change Agent and Advisory Board to work on children's services. Broeker stated he attended a DHS meeting in Des Moines last week and they stated it is entirely up to the County or Region to develop those services regardless of funding. IT Director Colin Gerst reported his office is busy and they are currently swapping out old PC's. County Attorney Lisa Schaefer reported her office is busy and they are preparing for a homicide trial starting next week. Another trial is set for the end of August. County Engineer Brian Carter reported the pavement blowup in Middletown has been repaired and the RR Crossing on old Hwy 34 is complete. Updates on Hwy 61 project road closures – Flint Bottom Road and Stony Hollow Road intersections are closed, and Seven Ponds Road is using the alternate route created to complete grading on original section. Carter reported the FEMA project on Golden Road. The road is closed for repairs due to the wing wall and guard rail on the bridge being lost during high water from a combination of erosion and land slide. They are replacing the wall with a gabion basket retaining wall. The Sperry Road bridge project should start soon to remove the old bridge and some grading. This will be a two to three-month project. Update on Hwy 99 Flint Creek bridge. Carter received a verbal report saying they are hoping to be in the final stages of approving permits. He still does not have permits. Once received he will work with the local levee district to get local permits. He has been attending their meetings and keeping them apprised of the progress. Carter stated he has started communication with adjoining land owners for additional right of way. The road crews are still patching Bridgeport Road in preparation for RAGBRAI. They should finish up by Wednesday. Conservation Director Chris Lee stated they are happy with the cooler weather this week. Camping last weekend was slower with the hot weather. All boat ramps are now in the water. Cary asked about ADA handicap walkways to Big Hollow Lake. Lee stated they are working on a lot of those issues and reviewing their strategic plan and other accessibility options including the steep boat ramp. Assistant Land Use Administrator Jarred Lassiter reported they are busy and have a few subdivisions in review.

Class C Liquor License for HyVee King Wedding at Barn on the Ridge 8/1 was presented. Cary motioned to approve and seconded by Beck.

Class C Liquor License for HyVee Tabor Wedding at Barn on the Ridge 8/8 was presented. Beck motioned to approve and seconded by Cary.

Class C Liquor License for HyVee Grothe Wedding at Barn on the Ridge 8/15 was presented. Beck motioned to approve and seconded by Cary.

Class C Liquor License for HyVee Welch Wedding at Barn on the Ridge 8/22 was presented. Cary motioned to approve and seconded by Beck.

Personnel Actions: Auditor's Office – Aurey Kramer, Clerk II. Resignation effective 7/15. Angie Paytes, Clerk II. New hire. New rate \$26,303.72 yr., effective 7/31. Beck motioned to approve both actions and seconded by Cary.

Cary motioned to approve the July 16th, 2019 meeting minutes and seconded by Beck.

Committee Reports: Cary attended a Community Action meeting. The revised employee handbook weapons portion will reference the Iowa Code. Cary also reported from the meeting the estimated population of Des Moines County is 39,876 with 5,218 of the population in poverty. Thirteen percent of those in poverty are senior citizens. He attended an Iowa Workforce meeting. It appears we will keep our local office, but it will not be fully staffed. Broeker attended an MHDS Services Commission meeting.

Public Input: Tom Courtney, 2609 Clearview, Burlington asked Cary about the poverty level in Des Moines County. He stated there are students in the Burlington School District that are considered homeless. He stated the county should be appalled at such statistics. CDS Director Ken Hyndman referenced several resources those in need can contact for assistance.

Meeting was adjourned at 9:41 AM.

Following the meeting were two work sessions:

The first work session was with the Board of Supervisors, Maintenance Supervisor and County Attorney. They discussed the issue with the front steps and flooding in the basement created by a water leak in the tubing to heat the steps during the winter. Assistant County Attorney Todd Chelf has more information on the issue but was not present. All present decided to reschedule the work session for July 30th.

The second work session the Board of Supervisors and County Engineer took a road tour.
