**SHALL THE FOLLOWING PUBLIC MEASURE  
BE ADOPTED?**

Shall the Board of Directors of the West Burlington Community School District, in the County of Des Moines, State of Iowa, for the purpose of purchasing and improving grounds; constructing schoolhouses or buildings and opening roads to schoolhouses or buildings; purchasing of buildings; purchase, lease or lease-purchase of technology and equipment; paying debts contracted for the erection or construction of schoolhouses or buildings, not including interest on bonds; procuring or acquisition of libraries; repairing, remodeling, reconstructing, improving, or expanding the schoolhouses or buildings and additions to existing schoolhouses; expenditures for energy conservation; renting facilities under Chapter 28E; purchasing transportation equipment for transporting students; lease purchase option agreements for school buildings or equipment; purchasing equipment authorized by law; or for any purpose or purposes now or hereafter authorized by law, be authorized for a period of ten (10) years, to levy annually, a voter-approved physical plant and equipment property tax not to exceed One Dollar and Thirty-Four cents (\$1.34) per One Thousand Dollars (\$1,000) of the assessed valuation of the taxable property within the school district commencing with the levy for collection in the fiscal year ending June 30, 2016, or each year thereafter?

Shall the Board of Directors of the West Burlington Independent School District in the County of Des Moines, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$6,750,000 to provide funds to construct, build, improve, furnish and equip classroom and gymnasium additions to the elementary building, including related remodeling and to improve the site; to construct, build, improve, furnish and equip a kitchen and cafeteria addition and media center addition to the junior/senior high school building; to remodel, renovate, refurbish, improve, furnish and equip portions of the junior/senior high school building and to improve the site?
