

June 23, 2015

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, June 23rd, 2015, with Jim Cary, Tom Broeker and Bob Beck present.

Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: Conservation Director Chris Lee reported that his crews are clearing downed trees following Saturday night's storm. The boat docks will remain out of the water until the river comes down. Big Hollow campgrounds was about half full over the weekend. Maintenance Supervisor Rodney Bliesener reported that the chimney cap on the Courthouse and the fence around the air conditioning unit were damaged by the windstorm. County Engineer Brian Carter stated that secondary road crews are getting rid of downed trees. DCS Ken Hyndman plans to attend a rally this afternoon to keep the MHI at Mt. Pleasant open. He will attend a jail transition meeting at Washington County on Wednesday. Hyndman stated that managed care is coming on July 1st and it's a tough time to build capacity when it isn't known how much funding for mental health will be available. Chief Deputy Jeff White reported a busy weekend.

The following correspondence was received: a letter from the Civil Service Commission announcing a vacancy. Interested persons are asked to send applications to the Auditor's Office. Also, a letter was received from Des Moines County Public Health notifying the Board of a meeting on July 16th for a community health needs assessment.

Accounts Payable Claims in the amount of \$1,153,924.09 were approved upon motion by Broeker and second by Beck.

Land Use Administrator Jeff Hanan presented the Resolution and Final Plat for Packer Lane Subdivision. Hanan stated that this is a minor one lot subdivision located at 12095 180th St. and recommended that it be approved. Motion to approve was made by Beck and seconded by Broeker.

NOW THEREFORE, BE IT RESOLVED: That the Board of Supervisors hereby approves the Final Plat of **Packer Lane Subdivision**.

Sperry Fireworks Company; Broeker moved to approve. Beck seconded. Hull Contracting Appreciation; Beck moved to approve. Seconded by Broeker.

The resignation of Mark R. Hagerla from the Civil Service Commission was accepted upon motion made by Broeker, who thanked Hagerla for his 24 years of service on this commission. Beck seconded.

The following personnel action was approved: at the County Attorney's office, Rob Bixlar has been hired as investigator. Bixlar will be paid \$15.39 per hour for no more than 15 hours per week. Motion to approve was made by Beck and seconded by Broeker.

The fiscal year 2016 Letters of Appointment for all county departments were approved upon motion by Broeker. Second by Beck.

Beck moved to approve minutes for the Board meeting held on June 16th, 2015. Seconded by Broeker.

During other business, Broeker reported that a conference call was held between Carosh Compliance Solutions and representatives of several departments regarding contracting with Carosh for HIPAA compliance. A letter of engagement will be sent to the Supervisors to be approved at next week's Board meeting.

During committee reports, Broeker had attended a COBCO Insurance Board meeting where the current officers were reelected. He also attended a meeting for Mental Health and Disabilities Services Commission. Broeker reported that a contract for bed tracking services begins June 29th. Beck attended a Board of Health meeting. Cary had attended an Early Childhood meeting where a provider contract was signed. The transition to include Washington and Henry counties with Louisa and Des Moines counties in this group is almost complete.

Meeting was adjourned at 9:48 AM.

A work session with Two Rivers Drainage District Trustees and the County Attorney to discuss contributing to the defense of Sac, Calhoun and Buena Vista counties against a lawsuit brought against them by Des Moines Waterworks. The majority of those speaking were in favor of assisting.

A work session was held with the County Attorney regarding her request for additional office space. An office suite adjoining the current office has become available. Broeker has approached U S Bank but had not yet received a response.
