

November 10, 2015

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, November 10<sup>th</sup>, 2015, with Jim Cary and Tom Broeker present. Bob Beck was absent.

Unless otherwise noted, all motions carried.

Meet with Department Heads: Chief Deputy Jeff White was commended by the Board and several department heads for conducting the intruder training last week. They agreed the training was very beneficial. County Engineer Brian Carter reported that it was not a county road grader involved in an accident yesterday. Also, crews found another hole under a paved road so they are replacing the culvert and repairing the road. Public Health Director Barb Baker is developing a new Homemaker Home Health Aide program.

Broeker moved to open a Public Hearing to adopt Des Moines County Ordinance #55, readopting all prior Ordinances as required per Iowa Code 301.302. Seconded by Cary. Cary read the Ordinance. Ordinance #3 will not be readopted as it refers to purchase orders, which the county no longer uses. There were no comments, written or otherwise, from the public. Motion to close the Public Hearing was made by Broeker and seconded by Cary. Broeker moved to adopt Ordinance #55 with the exception of Ordinance #3. Seconded by Cary. The second hearing will be on November 17<sup>th</sup>.

Judy Stuecker, President of CWA Union #7176, presented the initial proposals for the Clerical/Custodian contract. They are asking for an additional week of vacation and 5% salary increases for each of the three years in the contract.

Sheriff's Deputy Kevin Glendening presented the initial proposals for the Sheriff's Deputies/Correctional Officers. The deputies are asking for another six days of vacation and 5 % increase the first year, 3% the next two years. The correctional officers are asking for \$1 more per hour and six additional days of vacation.

The Supervisors returned their initial response/ proposal to AFSMCE Local 2205 on their proposal received on October 20, 2015. The Board proposes a one percent salary increase for each of the three years in the contract and is asking the employees to contribute towards their health insurance.

The lease between the County and Hope Haven to manage the Crisis Stabilization Center and the Cottonwood Residential Care Facility was approved upon motion by Broeker and seconded by Cary.

Contract documents for rock supplies were approved following the recommendation of the County Engineer. Carter stated that the rock will be paid for from Rural Services funds. Broeker moved to approve the contracts. Cary seconded.

The 2015 Utility Assessment was approved. Motion by Broeker and seconded by Cary.

Broeker moved to approve the 2015 Gas & Electric Assessment. Seconded by Cary.

Broeker moved to accept the resignation of Elizabeth Henriksen from the Des Moines County Compensation Board. Seconded by Cary.

Duane Worthy was appointed to fill the vacancy on the Des Moines County Compensation Board. Motion to approve was made by Broeker and seconded by Cary. Worthy will represent the Supervisors.

The following personnel actions were approved: at Community Services, Nancy Carey, Case Manager, resigned effective December 1, 2015. Approved upon motion by Broeker and second by Cary. At Public Health, Home Health Aides Cindy Hiland, Connie Hutchinson, Joyce King and Judy Weatherwax were hired at \$13.00 per hour. Broeker moved to approve. Cary seconded. At the Treasurer's office, Ashley Sherwood took 9.42 hours without pay. Broeker moved to approve. Seconded by Cary.
