

October 15th, 2019

The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, October 15th, 2019, with Chairman Tom Broeker, Vice-Chair Bob Beck and Jim Cary present.

The Pledge of Allegiance was conducted. Unless otherwise noted, all motions passed unanimously.

Meet with Department Heads: County Auditor Terri Johnson stated absentee voting for the City/School Election on November 5th is now available. Sample ballots are on the county website. Maintenance Supervisor Rodney Bliesener thanked everyone and all the departments, Burlington police and fire for their participation in the Active Shooter Training last week. Conservation Director Chris Lee reported the Halloween event at Big Hollow last weekend was a huge success with a large turnout. Lee thanked everyone that helped with the event and Garnjobsts, the campground hosts. The Halloween event for next year will be October 10, 2020 and camp site reservations for next year is already sold out. Assistant Land Use Administrator Jarred Lassiter stated there is an opening on the Zoning Commission board, John Roth has resigned. They are open for suggestions or new inquiries but prefer someone in the two-mile area south of Burlington. Sheriff Mike Johnstone was present. County Engineer Brian Carter stated Sperry Road is still closed. The Iowa Department of Transportation will have a bid letting today for the paving of the Highway 61 expansion project and the Iowa City Road. County Attorney Lisa Schaefer reported a misdemeanor attorney has been hired and may start next Tuesday. The Burlington Police Department will be announcing a permanent drug prescription drop-off site at the Police Station. The County Attorney is co-sponsoring the drop-off site. IT Director Colin Gerst reported his office is busy. Joint Safety Director Angie Vaughan agreed with the Maintenance Supervisor's comments regarding the Active Shooter Training and greatly appreciated everyone's participation in the shooter exercise. Vaughan further stated the C3 Deescalating training courses are continuing this week and thanked Ken Hyndman and Instructor April Krogmeier for assisting. CDS Director Ken Hyndman reported the Hope Haven annual meeting is October 28th. Hyndman, Alana with General Assistance and Rynane with SEIL will be talking to Iowa Works on November 6th about services they provide. Local Health Administrator Christa Poggemiller stated they are still providing flu clinics. County Treasurer Janelle Nalley-Londquist reported her office is busy. Sergeant Kevin Glendening reported one of the three new deputies has finished their training and out on their own. In a couple of months, the others will finish their training. Glendening reported the K-9 fundraiser was successful. Jim Jacks donated \$10,000 in memory of Calvin Kuntz. This puts them three-quarters of the way through their fundraising goal. Jail Administrator Doug Ervine reported everything is going well and the jail population is at 93.

Accounts Payable Claims in the amount of \$583,457.86 was presented. Cary motioned to approve and seconded by Beck.

Fireworks Permit from J&M Displays for Harvest View Farms on 10/17 was presented. Cary motioned to approve and seconded by Beck.

Correctional Center – Alexis Abney, Correctional Center Full Time. 6.55 hrs. unpaid leave effective 10/5. Nicholas Jeffries, Correctional Officer Full Time Sergeant. New Hire. New rate \$46,012.68 yr., effective 10/16. Beck motioned to approve both actions and seconded by Cary.

Public Input – No one spoke. Prior to adjournment Supervisor Beck thanked all the department heads for attending the board meeting.

Meeting was adjourned at 9:30 AM.
