The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, December 14th, 2021 with Chairman Tom Broeker and Vice-Chair Jim Cary present. Member Shane McCampbell was present through Webex. This meeting was also held electronically via Webex and YouTube live streaming. Public input was available through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: Sheriff Kevin Glendening reported the jail population is at 62 adults. 2 adults and 2 juveniles are being housed out of county. Glendening stated at the 911 Board Meeting they approved to pay part of the RMS/CAD system that is listed on the agenda for today. The Sheriff's office has two deputies that will be graduating the academy at the end of this week. Assistant Land use Administrator Zach James stated the office is busy working on subdivision and flood plain zoning. The RFQ for the new Public Health building has been mailed out. CDS Director Ken Hyndman reported he attended a SEIL meeting. His office is staying busy. Conservation Director Chris Lee reported his office is busy preparing for tomorrow's Conservation Board Meeting. County Engineer Brian Carter stated with the weather continuing to stay mild, his crew has been keeping busy ditching and grading roads. The office continues to stay busy getting paperwork buttoned up from the summer months. He will be attending the annual County Engineers Conference in Des Moines later this week. County Treasurer Janelle Nalley-Londquist reports her office as busy. County Auditor Terri Johnson stated her office remains busy working on redistricting that needs to be completed by January 15th. She has gotten the RFQ for the Public Health building and the RFP for the front steps posted on the County website. Maintenance Supervisor Rodney Bliesener reported his staff is busy. He has gotten the bids for the front steps out to our local contractors. Assistant County Attorney Trent Henkelvig stated the Attorney's office continues to be busy trying to catch up from Covid Court delays.

Correspondence. Chairman Broeker read an e-mail from Marlin Dubetz requesting that the Des Moines County Board of Supervisors considers voting to approve Des Moines County as a Second Amendment Sanctuary County.
