The Des Moines County Board of Supervisors met in regular session at the Court House in Burlington at 9 AM on Tuesday, October 11th, 2022, with Chairman Jim Cary and Member Tom Broeker present. Vice-Chair Shane McCampbell was present via Webex. This meeting was held electronically via Webex and YouTube live streaming. Public input is available in-person, through board email or call in.

Unless otherwise noted, all motions passed unanimously. The Pledge of Allegiance was conducted.

Meet with Department Heads: Auditor Terri Johnson gave an election update. The number of absentee ballot request forms received for ballots to be mailed has reached 1,543. The first day the office is allowed to mail the absentee ballots is October 19th. October 24th is the last day to pre-register and the last day to request a ballot to be mailed for the November Election. IT Director Colin Gerst reported his office is busy rolling out new equipment. He was at an IT event in Des Moines last week and toured the State of Iowa SOC office and they discussed security tools. Sheriff Kevin Glendening stated the jail population is 109 with 26 out of county. Arrests have gone up. They are interviewing for the Office Administrative Assistant position. Land Use Administrator Zach James was present for an agenda item. Conservation Director Chris Lee reported the Big Holloween event went well at the Big Hollow Park. There were about 800 trick or treaters and over 100 volunteers assisted. Thursday, Oct 13th is "Pints for Parks" event at Parkside Brewery to celebrate Conservation's 60 years. October 25th at 6pm the Conservation Board will have a public input meeting at the Drake to discuss how to use the buyout properties on the Tama Road corridor currently managed by Conservation. They will discuss possible uses which could be leasing the properties as campsites, no buildings allowed and will need to follow FEMA/Federal regulations. The Conservation Board will meet on November 2nd to discuss the October 25th results. SEIL CDS Director Ken Hyndman reported SEIL meetings will be held tomorrow. County Attorney Lisa Schaefer stated some of her staff are at a Victim Justice symposium in Des Moines. The attempted murder trial for the West Burlington pool shooting will start next week. Her office is co-sponsoring with Burlington Police Department a Domestic Violence Awareness Vigil on Oct 20th at 6:30 pm. This is an inaugural reboot of the vigils after the passing of Char Blodgett the past Director. The vigil will be in memoriam of Char. She attended the Empower U session for students and was very impressed with all speakers and the questions asked by the students. County Engineer Brian Carter reported temporary traffic lights were setup for work on the Hwy 99 Dry Branch Creek project. Two crossroad culverts are being installed. In general, everything is working OK with a few glitches in the light timing. He emphasized the construction site may be too tight for any farm equipment to pass through. The 115th Ave project is complete, just need some moisture for seeding. There is an opening for a motorgrader position, the job description can be found on the county website and in local papers. Maintenance Director Rodney Bliesener reported his department is busy. Public Health Administrator Christa Poggemiller reported her office is busy. Flu vaccine is available during clinics hours held on Tuesday and Thursdays from 8:30am to 4:00 pm by appointment or walk-in. There will be a couple of community clinics – October 12th at Danville Community Building from 1:00 to 2:30 pm and on October 19th at Mediapolis City Hall from 2:30 to 4:00 pm. They are waiting for covid vaccine for the 5 to 11 age group. She met with the architects to discuss the new public health building. County Recorder Natalie Steffener reported her office is busy.

County Attorney Lisa Schaefer explained the four resolutions being presented today and the need to set the hourly rate paid by the county per Iowa Code.
